

The Terms & Conditions of the Camp will be as under :-

1. Boarding @ Rs.340/- for outstation Campers
2. Lodging Charges up to @ RS.1000/day/person.
3. Coaches are common for Sr (M&W) approved vide sanction letter No. 41 dated 30 April 2014 and Jr. (B&G) approved as above and be given B&L for Sr camp only).
4. Petrol Charges :-
 - (i) Motor Boat Charter Fee Rs.12500/day for 03 Motor Boats for coaching for and 02 Rescue Boats @ Rs.2500/boat/day for the duration of the camp.
 - (ii) Expenses towards 30 ltr. of petrol per day for 05 Boats Rs.2400/day/boat@Rs.12000/boat/day (@Rs.80/ltr.) for five Boats for the duration of the camp.
5. Travelling by Train 2nd AC only.
6. Medical on Actual Basis.
7. Please ensure that the guidelines issued by the TEAMS Division for holding of National Coaching Camp is adhered to.
8. List of Campers, Coaches and Supporting Staff reported for the Camp should be forwarded to the TEAMS Division by 3rd day from the commencement of the Camp.
