I am directed to refer to your letter No. YAI/MatchRace/Russia/2014, dated : 25th June, 2014, on the subject mentioned above and to convey the approval of the Government for the participation of 04 Members Indian Senior Men Yachting Team, 04 Sailor in the Seven Feet Cup – 2014 to be held at **Vladivostok, Russia from 16th – 20th July, 2014.** Including Air Passage Cost with incidentals such as Visa Fee, Medical Insurance, Immigration Charges and Airport Tax etc.

- As per the provision of the scheme, the admissible assistance for Air Passage, Boarding/Lodging etc., would be provided to the above team members and detailed financial sanction for the above will be issued separately.
- Section 9 of FC (R) Act, 1976, provides inter-alia that no Member of a legislature, office bearers of a political party, Judge, Government Servant or employee of any Corporation shall accept any foreign hospitality without prior permission of the Central Government. In case, any team member is covered under the above Act, he/she should obtain the prior permission from Ministry of Home Affairs before his/her departure to **Russia**.
- Such of the team-members who might be Central Government Servants are to be treated as on duty (which include deputation abroad) in respect of this participation by the Department/Office in which they are employed in terms of Department of Personnel & Training O.M. No. 6/1/85-Estt. (Pay-I) dated 30.1.1989. The Federation should inform their employing Department/Office accordingly.
- It is requested that Embassy of India, **Russia** and Organizers of the event may please be informed by fax of the travel plans and itinerary of the team for participation in the above event. The team members may be advised to call on the Mission for exchange of views.
