M. No. 6/1/85-Estt. (Pay-I) dated 30.1.1989. The Federation should inform their employing Department/Office accordingly.
- 5. It is requested that Embassy of India, **Abu Dhabi** and Organizers of the event may please be informed by fax of the travel plans and itinerary of the team for participation in the above event. The team members may be advised to call on the Mission for exchange of views.

- 7. Before departure, a report on dope test of the team members may please be obtained from NADA.
