ELECTION OF OFFICE BEARERS AND COUNCIL MEMBERS OF THE YACHTING ASSOCIATION OF INDIA

- The election of the Office Bearers and Council Members of the YAI was completed on 26 August 2013 and the members elected for a term of four years. However, consequent upon resignation of Admiral (Retd) DK Joshi,PVSM,AVSM,YSM,NM,VSM as President, Lt Gen (Retd) Sharma, PVSM, AVSM as Vice President, Vice Admiral (Retd) Shekhar Sinha, PVSM, AVSM, NM & Bar, ADC as Chairman National Classes Committee and Lt Gen I Sikand, VSM, ADC as Chairman Youth Classes Committee of the Yachting Association of India (YAI), the said posts have fallen vacant. The next election of office bearers and Council Members of the YAI will be due on 25 Aug 2017. In order to fill in the vacant posts for remainder terms of the Council ie upto 25 Aug 2017, it is proposed to convene a Special General Body Meeting on 29 August 2014 at New Delhi for the conduct The elections will be conducted in accordance with the provisions contained in the YAI Constitution read in conjunction with the "Model Election Guidelines" as promulgated at Annexure XXXVII of the National Sports Development Code of India 2011.
- 2. Article 16 (a) of the YAI Constitution entitles "Member Clubs" of the YAI to ONE vote each at the General Meetings. With a view to prepare the Electoral College as required in Form No 1 of the "Model Election Guidelines" of the National Sports Development Code of India 2011, the

President or Secretary of the affiliated State Association, President or Vice President of the affiliated Class Association and Commodore or the Vice Commodore of the affiliated Sailing Club is required to appoint by name a Life Associate Member of the YAI as its representative who shall exercise all its rights of voting at the General Body Meeting.

- 3. In case the President or Secretary of the affiliated State Association, President or Vice President of the affiliated Class Association and Commodore or the Vice Commodore of the affiliated Sailing Club nominate different person, the person authorised by the President of the affiliated State Association, President of the affiliated Class Association and Commodore of the affiliated Sailing Club shall be deemed to be the duly authorised person irrespective of the date of authorisation.
- 4. Each affiliated Member Club is therefore requested to intimate the name of its representative latest by 13 August 2014. This intimation must be addressed to the Hon Secretary General on the letter head of the Member Club duly signed by the President or Secretary of the affiliated State Association, President or Vice President of the affiliated Class Association and Commodore or the Vice Commodore of the affiliated Sailing Club. Any change in the name of any authorised representative after 13 August 2014 or any intimation received thereafter shall only be permitted with the approval of the Acting President of the YAI.
- 5. On receipt of the above information, I shall prepare the list of authorised representatives of Member Clubs in Form 1 as promulgated in the Annexure XXXVII (Model Election Guidelines) of the National Sports Development Code of India 2011. I shall also circulate the list so prepared by me to all Member Clubs, latest by 14 August 2014, by display on the website of the YAI www.yai.org.in
